



Lot Owner Request to Operate an ATV/OHV within Timber Lakes

Purpose: All ATVs/OHVs operated within Timber Lakes require an annual permit, whether they are street legal ATVs or recreational OHVs registered with the State of Utah.

Eligibility: Only ATVs/OHVs with current valid Utah registrations and verified as owned by Timber Lakes lot owners may be issued permits. Proof of registration must be presented and verified before a permit is issued.

Fee: Fee is \$20 per machine. Fee shall be waived for all ATVs/OHVs with current valid registrations and license plates issued by the State of Utah. Plate must be current and always visible on the machine during the permit period.

- Indemnification:** I agree to indemnify, defend, and hold harmless TLPOA for any injury, claim, damage, or action of any kind that arises out of or relates to the uses of an ATV/OHV within Timber Lakes by me or by any guest or invitee of mine or by a resident or guest of my lot. _____.
- I agree that no one under the age of 8 will operate any ATV/OHV/machine on Timber Lakes roads, common areas or properties. _____.
- I agree that any guest, resident, or invitee of mine who is 8 years of age or older and 17 years of age or younger operating an ATV/OHV without a valid driver's license will have a State of Utah OHV certification and will have adult supervision. _____.
- I agree that all riders and passengers under 18 years old must wear a helmet when riding any ATV/OHV, including motorcycles, ATVs, 4-wheelers, and non-enclosed UTVs. _____.
- I agree to abide by all TLPOA road regulations including maximum speed limits of 25 mph and will not park on any roads at any time for any reason. _____.
- I agree to place the TLPOA permit stickers on the left side of the machines, clearly visible, and will not move them from machine to machine. _____.
- I and any guest, invitees, or resident of my lot will stay on the designated roads and will not trespass on other's private property, common areas, trails, lake beds or other protected property. _____.
- I have read the TLPOA rules, and I understand that failure to follow these rules will result in issuance of a fine. I agree and understand that I am responsible for any guest, resident or invitee of my lot and I understand and agree that I will be issued a fine for any violation of these rules by any guest, resident, or invitees, I am responsible for such fines and I will inform all persons with me of these rules and regulations. _____.
