

## Lot Owner Request to Operate an ATV/OHV within Timber Lakes

Purpose: All ATVs/OHVs operated within Timber Lakes require an annual permit, whether they are street legal ATVs or recreational OHVs registered with the State of Utah.

Eligibility: Only ATVs/OHVs with current valid Utah registrations and verified as owned by Timber Lakes lot owners may be issued permits. Proof of registration must be presented and verified before a permit is issued.

1.	Caution: I understand and agree that I operate OHVs at my own risk. Timber Lakes roads, common areas and property are not patrolled or maintained for safety. Operation of an ATV/OHV can result in property damage, severe injury, or death. TLPOA assumes no liability for the operation and use of any form of transportation (motorized or non-motorized) including but not limited to snowmobile, ATV, 4-wheeler, side-by-side, UTV, motorcycle, skis, sleds, etc				
2.	<b>Indemnification:</b> I agree to <u>indemnify, defend, and hold harmless TLPOA</u> for any injury, claim, damage, or action of any kind that arises out of or relates to the uses of an ATV/OHV within Timber Lakes by me or by any guest or invitee of mine or by a resident or guest of my lot				
3.	I agree that <u>no one under the age of 8 will operate any ATV/OHV/machine</u> on Timber Lakes roads, common areas or properties				
4.	I agree that any guest, resident, or invitee of mine who is <b>8 years of age or older and 17 years of age or younge</b> operating an ATV/OHV <u>without a valid driver's license will have a State of Utah OHV certification and will have adult supervision</u> .				
5.	I agree that all riders and passengers <u>under 18 years old must wear a helmet</u> when riding any ATV/OHV, including motorcycles, ATVs, 4-wheelers, and non-enclosed UTVs				
6.	I agree to abide by all TLPOA road regulations including <u>maximum speed limits of 25 mph</u> and <u>will not park on any road</u> s at any time for any reason				
7.	I agree to place the TLPOA permit <u>stickers on the left side</u> of the machines, clearly visible, and will not move them from machine to machine				
8.	I and any guest, invitees, or resident of my lot will stay on the designated roads and <u>will not trespass</u> on other's <u>private property</u> , <u>common areas, trails, lake beds or other protected property</u> .				
9.	I have read the TLPOA rules, and I understand that failure to follow these rules will result in issuance of a fine. I agree and understand that I am responsible for any guest, resident or invitee of my lot and I understand and agree that I will be issued a fine for any violation of these rules by any guest, resident, or invitees, I am responsible for such fines and I will inform all persons with me of these rules and regulations.
